Dear ECUSC Board members,

I am writing to advise that the Essex County Soccer Association ("ECSA") Board of Directors held a meeting on July 31, 2017 in order to discuss the future of the District's Regional (L3) representation currently being undertaken by ECUSC.

This meeting was further to a meeting held on July 13, 2017 between both ECUSC and ECSA Boards at which time a number of issues were discussed.

I can now advise that as a result of our above-noted meeting held last evening **ECUSC's position as the District's Regional (L3) representative for 2018 and beyond is under formal review and the within correspondence shall serve as your notice of the same.**

As part of the ECSA's formal review process, ECUSC is required to meet the below noted conditions:

- i. ECUSC shall have a **Constitution and By-Laws** in place no later than August 17, 2017 and provide a copy of the same to ECSA;
- ii. ECUSC shall provide ECSA with a list of all **Club appointed ECUSC voting members** and the name of an **alternate voting member** by August 17, 2017
- iii. ECUSC shall provide to ECSA the names of **all coaches** appointed for the U13-U14 boys and girls teams in 2018 including their present **coaching licensing qualifications** no later than August 17, 2017;
- iv. ECUSC shall provide to ECSA the **names of all players** and **associated email addresses** selected for the U13-U14 boys and girls teams in 2018 no later than August 17, 2017;
- v. ECUSC shall **immediately cease** its U8-U12 boys and girls All Star program per 2015 ECSA AGM motion prohibiting the same;
- vi. ECUSC shall not have any U8 through U14 boys and girls players **play or register** in the USA as a USA based team or as a ECSA Club team affiliated with a USA based team failing which WRSL (L3) playing rights shall be **immediately terminated**;

- vii. ECUSC shall not have any coaches **coaching** in the USA for a USA based team or as a ECSA Club team affiliated with a USA based team failing which the subject matter coach will not be eligible to be considered for a ECUSC coaching position;
- viii. In the event that ECUSC **wishes to participate in a USA** based League they shall forthwith undertake the established process of obtaining both Essex County District Association (ECSA) and Ontario Soccer (OS) approval for the same and shall register to play as ECUSC and under no other name;
- ix. No later than August 17, 2017 ECUSC shall provide ECSA with a detail of **all the circumstances** surrounding its **U13 girls team** which was never registered as a ECUSC team and to date has forfeited four (4) WRSL games and what will be done to prevent a similar circumstance in the future;
- x. ECSA shall undertake a **final review** of the ECUSC program no later than **August 31, 2017** at which time a decision will be made to renew or cease the ECUSC program as the District Representative at the Regional (L3) level;
- xi. The ECUSC Board shall send communication **via registered mail (or an alternate method of communication acceptable and approved by the ECSA Board)** to all parents of players U8 to U14 parents advising that the ECUSC program in **currently under review** by the ECSA Board and advising of all the above-noted conditions imposed on the Club. Evidence of the same being completed shall be provided to ECSA by August 17, 2017.

Please be further advised that the fulfilment of the above-noted conditions will **not result in the automatic renewal** of ECUSC as the District Representative at Regional (L3) level.

The formal review process will take into consideration **all** the particulars of the ECUSC program, including but not limited your responses to the conditions herein imposed, and will occur **as soon as August 18, 2017 and no later than August 31, 2017.**

The ECSA Board requests that each ECUSC member Club distribute a copy of the within letter to its membership for information purposes as well as posting a copy of the same on their respective web-sites.
